#### SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Flammable liquids (Category 2). Highly flammable liquid and vapor (H225). Keep away from heat, sparks, open flames, and hot surfaces. No smoking (P210).

Hazard class: Aspiration hazard (Category 1). May be fatal if swallowed and enters airways (H304).

#### SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Organic #3. Store with hydrocarbons, oils, esters and aldehydes.

Store in a dedicated flammables cabinet. If a flammables cabinet is not available, store in Flinn Saf-Stor $^{TM}$  can. Keep container tightly closed (P233). Use only in a hood or well-ventilated area (P271). Use explosion-proof electrical and ventilating equipment (P241).
